

**FACTS****WHAT DOES Watson Mortgage Corp. DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

<b>How?</b>	All financial companies need to share <b>Customers</b> personal information to run their everyday business. In the section below, we list the reasons financial companies can share their <b>Customers</b> personal information; the reasons <b>Watson Mortgage Corp.</b> chooses to share; and whether you can limit this sharing.

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

## Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Florida Insurance Concepts, LLC, Watson Realty Corp., Watson Maintenance Services, Inc., Watson Title Services of N. FL, Inc., Watson Title Services, Inc.*

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- ***Watson Mortgage Corp. does not share with nonaffiliates so they can market to you.***

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- ***Realty, Insurance, and Title Services***

## Other important information

**Watson Mortgage Corp. does not share Social Security Numbers, credit scores, income, assets, or liabilities with any affiliate companies or 3rd parties unless required for the sale of your mortgage to a loan servicer.**
